

Oklahoma Supreme Court Voter Guide 2026

The Supreme Court was set up to play an important role, to bring a vital system of checks and balances necessary to keep our government accountable to the people. **As the judicial arm, its role is to interpret law ONLY, not write it or alter it!** Unfortunately, in Oklahoma, our court has consistently and systematically applied law and court procedures in an unfair and unbalanced manner. OK Supreme Court has overreached its role by **striking down or overturning existing laws** by citizens and Governor, by interpreting them in a way that adds or ignores their original intention.

Of the **nine judges** who currently sit on the bench, there are **three, Kuehn, Rowe, Kane,** who **upholds the US constitution** and conservative principles held by the citizens of our state. A **4th Judge, Travis Jett,** newly appointed by Governor Stitt, has voted Conservatively so far. With current 5 Judge Liberal majority, who consistently act as “activist judges” trying to re-write THE LAW, INVENT NEW or OVERTURN laws PASSED BY THE HOUSE, SENATE, AND SIGNED BY THE GOVERNOR.

In 2023-25, Our OK Supreme Court Overturned Five (5) Pro-Life Laws Passed by Legislature to Restricting Abortion, and Save Babies (Plus, Overturned Part of Law for Elections and Mask Mandates)

The Court has betrayed its’ purpose and our citizens by ruling against individual freedoms when it came to mask mandates, weakening election integrity and mis-interpreting the Establishment Clause (RESURRECTING illegal ruling of separation of church and state) by overturning a decision to allow public funding to a Catholic charter school, suit brought by OK-AG Drummond. **A DISGRACE TO OKLAHOMA.** In 2015, the Court (Current Justices Winchester, Edmonson & Gurich voted) ***ruled the Ten Commandments monument on state capitol grounds must be removed, Overturned a District court judge ruled “it did not violate our State Constitution.”***

The Overturned ABORTION Bills:

Senate Bill 1503 **Prohibited abortion after a fetal heartbeat is detected** (usually around 6 - 10 weeks), with exception if the mother’s life is in danger. It would also have allowed any person to sue individuals who perform or help with an abortion that violates the law. This law was passed by the Senate and House, signed into law by **Governor Stitt on May 3, 2022.**

Overturned by: Justices Darby, Kauger, Winchester, Edmondson, Combs, Gurich

Opposed by: Justices Rowe, Kane, and Kuehn. Case 120543, Decided 3/21/2025 Case #120376, Decided 5/31/2023.

Bills OK Supreme Court Overturned the Vote of the People

OVERTURNED Bills Against Abortion (Cont.)

House Bill 4327 Was even stricter than **SB1503** prohibiting all abortion from the time of conception (not from the time a heartbeat is detected), with Exceptions in case of rape, sexual assault, or incest or if the mother's life is endangered. Like **SB1503 Bill**, an individual could sue anyone who performs/helps with an abortion. Governor signed 05/25/2022.
Overturned by Justices: Darby, Kauger, Winchester, Edmondson, Combs, and Gurich,
Opposed by: Justices Rowe, Kane, and Kuehn. Case #120376, Decided 5/31/2023.

Senate Bill 778 created the Oklahoma Abortion Inducing Drug Risk Protocol Act which enacted regulations on the use of abortion-inducing drugs. It required an ultrasound be conducted 72 hours prior to the day of abortion. It put parameters on physicians requiring them to be CERTIFIED to prescribe these drugs, obtain informed consent to women seeking the drugs and mandating doctors report data on the outcomes of the usage of these drugs, including complications. It attempted to protect women's health by creating a standard on how these medications are administered and monitored to save lives. A study has shown that the abortion pill mifepristone is 22 times more dangerous than previously claimed and 1 in 10 women suffer severe complications, with 36 dying by FDA 2022-24. Case #120376, Decided 5/31/2023/Case #119918 Decided 11/14/2023.
Overturned by: Justices Darby, Kauger, Winchester, Edmondson, Combs, Gurich.
Opposed by: Justices Rowe, Kane, and Kuehn.

Senate Bill 779 pertains to abortion inducing drugs, but with a focus on the supply chain side instead of the physicians' practices. It required the State Board of Pharmacy to establish rules for tracking the manufacturing and distribution of these drugs in the state to ensure their proper handling and certification. With the increase in chemical abortions in lieu of surgical abortions, the goal was to protect the women using these drugs by aiming for regulatory control over distribution and logistics mandating requirements and reporting obligations.
Overturned by: Justices Darby, Kauger, Winchester, Edmondson, Combs, Gurich.
Opposed by: Justices Rowe, Kane, and Kuehn. Case #119918 Decided 11/14/2023.

House Bill 1904 required only Oklahoma licensed physicians who are board certified in obstetrics and gynecology could perform abortions and only when necessary to save the life of the mother in a medical emergency Governor signed 4/26/2021. Case #119918 Decided 11/14/2023
Overturned by: Justices Darby, Kauger, Winchester, Edmondson, Combs, Gurich.
Opposed by: Justices Rowe, Kane, and Kuehn.

OVERTURNED NO MASKS on Children, Gave Power to Schools Boards:

Senate Bill 658 Stopped Covid 19 Vacs, Covid Vac Passports, & stopped school's ability to require mask mandates on children. If Governor declares emergency, board must clearly state purpose & type of mask, reason, and must be reconsidered at every board meeting to be removed. OK Supreme Court overturned part of the bill in part, stating unconstitutional and gave back to school boards authority to decide on mask mandates. Case #119840 Decided 9/20/2022
Overturned by: Justices (Darby, Kauger, Winchester, Edmonson, Gurich, Rowe, Kuehn with Combs concurring in part and dissenting in part.) Justice Kane was recused

Science Has Proven Masks are Horrible for Children and Adults:

ELECTION INTEGRITY:

2020 Lawsuit filed by League of **Women Voters vs the OK State Election Board** went straight to OK Supreme Court, against requirement absentee ballots must be notarized. **Oklahoma law required an notarized affidavit voter is qualified to vote, he/she personally marked the ballot, and has not shown the marked ballot to any other person.** OK Supreme Court Overturned Notarized Affidavit and allowed a personal signed statement with danger of perjury. **Overturn by:** Justices **Gurich, Darby, Kauger, Edmondson, Colbert, Combs,** **Opposed by:** Justices **Rowe, Kane, and Winchester dissented.**

OK Supreme Judges REWROTE Bill and STOPPED Catholic School Charter on False Ground of Separation of Church and State

(US Supreme Court had RULED NO SEPARATION OF CHURCH & STATE in 4 Cases, Court Overturn the Lemon Law, a Woke Case, thus overturned over 3,000 cases in US.

A Tulsa Catholic school applied to operate as state's virtual charter school program. OK school board voted yes to admission. **Attorney General Gentner Drummond filed suit against the OK Statewide Charter School Board** on grounds it violated separation of church and state. The OK Supreme Court Voted use of public funds for a religious institution was a violation, overriding the decision of the Charter School Board.

Overturned by: **Darby, Kauger, Winchester, Edmondson, Combs, and Gurich,** **Opposed by:** **Kuehn, and Rowe** partially overturn/partially opposed. *Kane recused* **Case #121694 Decided 6/25/2024** This case went to the US Supreme Court, decision was split 4-4, thus, OK SC Decision stands. *Justice Amy Barrett Recused herself.*

OTA ABUSE OF AUTHORITY BY PSEUDO GOVERNMENT AGENCY

This Case Involved taking 100s of homes and Farmland through Eminent Domain. The City of Norman is fighting against the **Oklahoma Turnpike Authority's plans** to build an extension highway through the city due to the elimination of hundreds of homes through eminent domain, disturbing quality of human and wildlife habitat, destroying farm land, **interfered with stormwater runoff**, and environmental threat to Watershed area (affect water supply). They filed a lawsuit claiming OTA was vague/deceptive about agreements, violated the Open Records Act, Challenged Legality of the project in the area that OTA wants to build, and **was not legislatively authorized.**

City of Norman Residents Wins in Appeal Court

Appeals Court Agreed with citizens **OTA had acted in bad faith.** OTA took this to the Liberal OK Supreme Court Majority who **VOTED with OTA**, overturned Appeals court decision and validated \$500 million in bonds for the project – **putting Oklahomans in Debt. A dissenting opinion** written by **Justice Rowe stated this gives OTA “incredibly broad discretion without any cognizable limits.** The OTA is apparently free to blatantly disregard the Legislature's directives with respect to routes and funding, **setting a new precedent** that future bond applications seeking our approval are merely seeking our rubber stamp.” **OTA has NO oversight.**

Overturned by: Justices **Darby, Kauger, Winchester, Edmondson, and Gurich.**

Opposed by: **Rowe, Kuehn,** Kane recused Himself **Case #120619,** Decided 8/1/2023.

DARBY Voted to Overturn all 5 Bills Against Abortion (SB1503, HB4327, SB778, SB779, HB1904)

Some of his Votes the following Cases:

1) Voted to Overturn legislation passed by *state restricting abortion either after a fetal heartbeat is detected and, in the case, to save the life of the mother in a medical emergency*, called it **unconstitutional, thus **there is now a limited right to abortion**. (Oklahoma Call for Reproductive Justice v. State)**

2) VOTED FOR Waiving the requirement that absentee ballots must be notarized (League of Women Voters v. Ziriaux), (NEED DATE)

3) VOTED to strike down a law that Prohibits Schools from instituting mask mandates on kids unless the Governor declares a state emergency which **(moves the authority from the Governor to the local school boards)**

Kuehn was appointed by Governor Kevin Stitt on July 26, 2021. Before appointed, 2017, Gov Mary Fallin appointed her Presiding Judge of the Oklahoma Court of Criminal Appeals serving a 2-year term. Dana is the first woman in OK history to serve on both courts. A native of Tulsa, she attended OSU, receiving a Degree in Political Science, a top ten graduate of the OSU College of Arts & Sciences. She received her JD from the University of Tulsa College of Law in 1996. After graduating, **Judge Kuehn was a felony prosecutor for ten years with the Tulsa County District Attorney's Office. As lead counsel, she tried more than 75 cases. She headed the Crimes Against Children Unit and served as Chief of the Juvenile Division.** In that capacity, she collaborated closely with Women In Recovery for alternative sentencing options for women. Judge Kuehn presided over additional civil docket from 2008 to 2017 conducting more than 100 jury trials.

Judge Kuehn served as Chief of the Civil Division at Tulsa County from 2010 through 2012. She teaches Juvenile Law and Evidence Workshop at the University of Tulsa College of Law. She is a recipient of the 2016 Mona Salyer Lambird Spotlight Award. In 2017, the American Board of Trial Advocates named her Judge of the Year for the State of Oklahoma. In May 2017, she was inducted into the Tulsa College of Law Hall of Fame and received the Thomas Coffman Community Service Award. Judge Kuehn is married to Patrick Kuehn and a proud mother of four boys. She is a Youth Deacon at her church, Kirk of the Hills Presbyterian. Favorite past-times are volunteering for her school, school sports teams, and reading history.

Formerly was a district judge in Osage County as District Judge for the 10th Judicial District. He was appointed by Gov. Kevin Stitt, R-Tulsa, in 2019 to fill the vacancy for District 1 created by the retirement of Justice John F. Reif. Kane was president of the Oklahoma Judicial Conference from 2013-2014, presiding judge-elect of the Northeastern Judicial Administrative District in 2019, and presiding judge of the Oklahoma Court on the Judiciary in 2019. Kane was as an administrative law judge for the Department of Human Services-Child Support Division from 1999-2005 and as an assistant district attorney from 1987 to 1989. In 2010, Kane was re-elected to the district court after running unopposed. In 2014, he got 75 % of the vote and beat Phil Best in the general election on November 4. Other judges in his district before supreme court stated he was “fair to a fault, a strict constitutionalist and equally empathetic to the businessperson and the homeless person.”

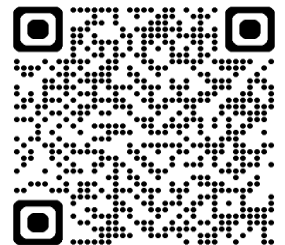

Appointed by Stitt in 2025, **a track record of defending agricultural interests, justifying religion in government and fighting against Medicaid expansion in the state** - represented OCPA when the group tried to stop State Question 802, also known as Medicaid expansion, Dissenting vote on Hodara V OK Dept of Corrections **Endorsed by** OK House speaker Kyle Hilbert, OK Senate President Pro Tem Lonnie Paxton, Retired state Justice Steven Taylor, State Chamber of OK Pres/CEO Chad Warmington. Dissented in case of Hodara v Oklahoma siding with Hodara that the state must produce material concerning the drugs used in state executions of capital crimes and not to do so is a violation of the Open Records Act. Judge Winchester Case ruling is mainly Leans Originalist (Constitutionalist) James was appointed as a member of the Supreme Court of Oklahoma by Governor Frank Keating in 2000. He served as Chief Justice of the Court from January 2007 to December 2008. His Case ruling 4/5 VOTE Struck down legislation designed to reduce drunk driving as violative of the single-subject rule. One of majority judges who forced the removal of the Ten Commandments Statue from the Oklahoma Capitol, claiming it violated Oklahoma's Unconstitutional Blaine Amendment. (A failed constitutional amendment) In recent cases involving abortion, has sided with the more Liberal Judges. Also was in favor of striking down the law prohibiting schools from enforcing mask mandates on children.

In review of case rulings, Justice Combs ruled against the ultrasound law to be performed before any woman had an abortion so they could be fully informed in Nova Health Services vs Pruitt 2012. He has participated in multiple abortion related cases each holding up baby death by abortion. As well has participated in cases taking some textualist approach. He has also ruled against protection for workers in Workers Comp cases. (Maxwell v Sprint PCS, Torres v. Seaboard Foods, and Mullendore v. Mercy Hospital Ardmore) Combs was born October 17, 1951, in Shawnee, Oklahoma. He attended St. Gregory's Junior College for one year on an athletic scholarship, transferred to the OU, gaining degree in Political Science in 1973 and JD law degree from Oklahoma City University in 1976. In 1982, he opened his own law office in Shawnee. became Vice Chief Justice from 2015 to 2016 and Chief Justice from December 1, 2016 – 2018, and a member of the Oklahoma Court on the Judiciary, Appellate Division.

Appointed by Gov. Brad Henry in 2011. Served as Chief Justice from 2019-2022 after serving as Vice Chief Justice from 2016-2018. Born and raised in Indiana, she graduated from Indiana State University but received her law degree from the University of Oklahoma where she served as an editor of the law review. She has served as an Oklahoma judge for 34 years, working in the Worker's Compensation Court for 10 years, as a district judge for 12.5 years. She also practiced law in OKC for 10 years. In the three OCFRJ v. Drummond cases, Gurich joined the majority opinions that found the Oklahoma Constitution protected a limited right to an abortion to protect the life of the mother and struck down the state's strictest abortion laws. Since her last retention election, many of the majority opinions she has written have focused on employment law, probate law, and family law. Dissented in the case of McGirt v. Oklahoma which determined that the plaintiff is not entitled to a state income tax exemption she sought as a resident of Indian Country reservations. Justices Edmondson and Combs agreed with Gurich. She has also ruled against protection for workers in Workers Comp cases. (Maxwell v Sprint PCS, Torres v. Seaboard Foods, and Mullendore v. Mercy Hospital Ardmore) along with Justices Edmondson and Combs. Part of a ruling of civil procedure to invalidate Oklahoma's requirement that mail-in ballots be notarized. Along with Justice Edmondson was part of a landmark ruling that forced the removal of the Ten Commandments statue from the Oklahoma Capitol, claiming it violated Oklahoma's unconstitutional Blaine Amendment. Dissented in a case in which the majority vacated a protective order granted against a street preacher for exercising his First Amendment rights (along with Combs & Edmondson) **Voted to strike down law that prohibited schools from instituting mask mandates on kids.**

Appointed by Gov. Brad Henry From a prominent democrat state political family, son of former US Congressman Ed Edmondson, nephew of former US Senator and OK Governor J. Howard Edmondson's brother of former Atty. General Drew Edmondson. His daughter Sarah was given a prison sentence for a crime spree that involved armed robbery and murder, allegedly inspired by watching the movie Natural Born Killers. He served in the US Navy and got his law degree from Georgetown University.

This year (2024), Edmondson was the only partial (albeit unwritten) dissent in the unsuccessful appeal of a public nuisance claim brought by survivors of the Tulsa Race Massacre. He was also the only justice to vote for the survivor's petition for a rehearing in front of the court. Edmondson joined the narrow majority of justices who held that the Oklahoma Constitution protected "an inherent right of a pregnant woman to terminate a pregnancy when necessary to preserve her life" in Oklahoma Call for Reproductive Justice v. Drummond I. He joined the majority in two cases of the same name — OCFRJ v. Drummond II and OCFRJ v. He then became first assistant attorney general. In 2012, he was named special judge in the 9th Judicial District (Logan and Payne counties). He was a commissioner for the OSBI for almost 10 years. He is a deacon in the First Baptist Church of Guthrie. **Considered a "Mild Republican" in the Confidence Score.** In 2020, he authored a 3-2 opinion upholding a life sentence for murderer Michael Bever, stating state law does not require courts to eventually guarantee freedom for such individuals, particularly when multiple crimes are involved. In McCauley vs State overruled the defendant's claim, the court lacked jurisdiction to rule on a murder because the crime occurred within the boundaries of the Osage Reservation. Hudson has consistently upheld the state's jurisdiction in criminal cases where it has been challenged by natives claiming to fall under Reservation jurisdiction (City of Tulsa-v-O'Brien, Irwin-v-State).
